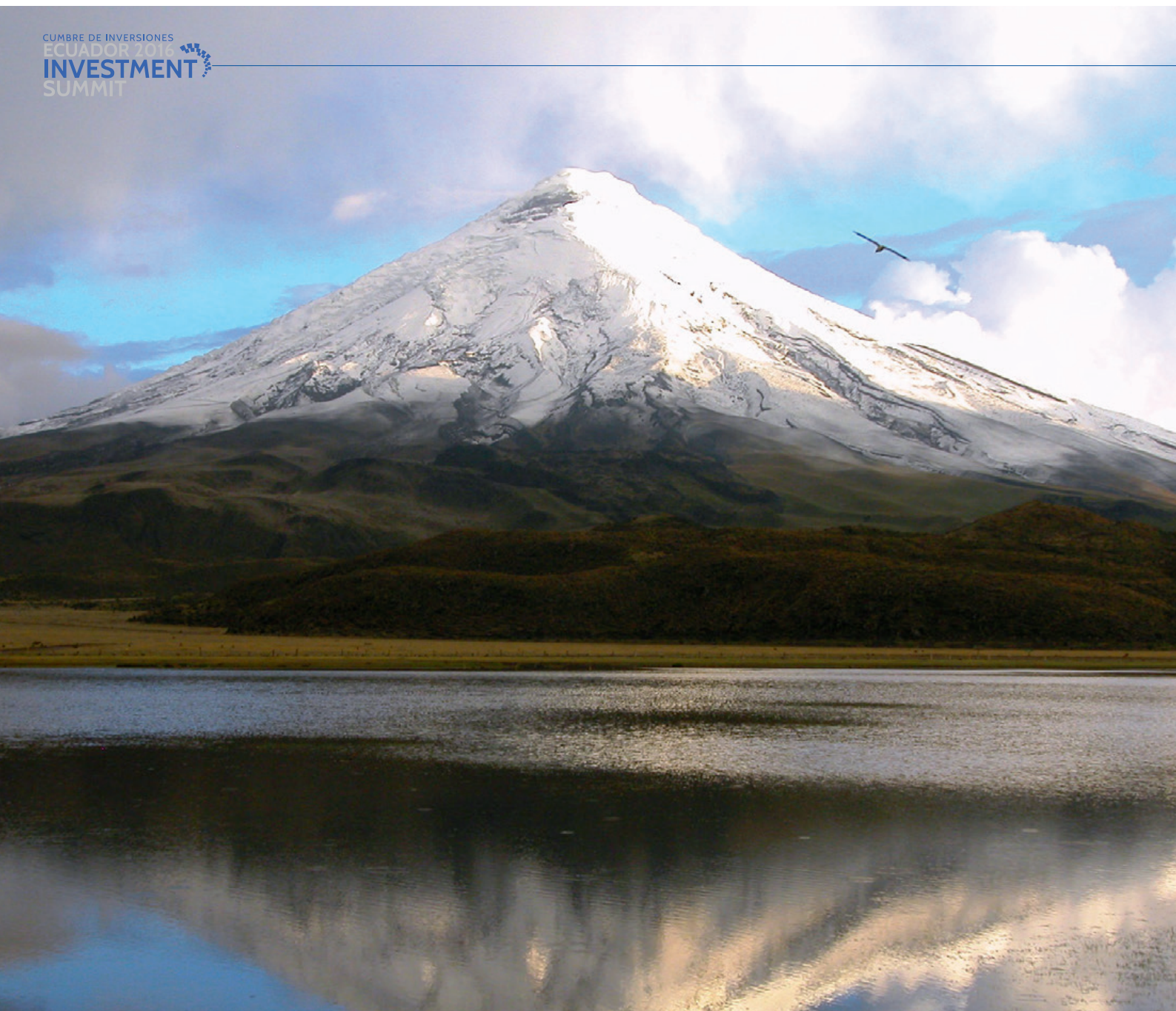






## SUMMIT OBJECTIVES
